#### QUALIFICATIONS FOR ADMISSION

1. Bachelor's degree or equivalent from an accredited institution in any fields
2. A minimum CGPA of 2.00 on 4.00 scale
3. Adequate undergraduate training to do graduate work in the M.B.A. Program
4. Good command of English
5. Computer literacy

#### ENTRANCE REQUIREMENTS

1. A completed application form
2. Official transcript of the previous university attended (2 copies)
3. Bachelor's degree certificate (2 copies)
4. Citizen identification card and residence registration (2 copies) - for Thai applicants
5. Passport (2 copies) - for Non-Thai applicants
6. Four (1x1 inch size) photographs (formal attire, not in graduation gown)

*Note: All documents must be endorsed with signature and submitted in person within the last day application period, otherwise the application will not be considered and the applicant will not be allowed to sit for the Admission interview.*

#### ADMISSION & EXAMINATION FEES (NON REFUNDABLE)

- AU English Proficiency Test Baht 500
- Interview Entrance Examination Baht 500

#### EXEMPTION

The English entrance examination can be exempted depending on which of the following conditions you satisfy.

- a TOEFL score of (iBT) 90 or (PBT) 575 or an IELTS (Academic) score of at least 6.5 (Validation: Two years)
- a Bachelor's degree or a higher degree from native English speaking countries (e.g. USA, Canada, UK, Australia and New Zealand)

#### ADMISSION REQUIREMENTS FOR ST. MARY'S UNIVERSITY

- overall 6.0 IELTS with no component below 5.5
- Eligibility for a student visa to study in UK
- CGPA for AU-MBA at least 3.0
- A minimum CGPA of 2.60 on 4.00 scale (undergraduate level)
- Related undergraduate study including; Tourism, Business Management or Management Studies, Hospitality, Geography or undergraduate programmes with significant business management content. Applicants with appropriate professional experience in the travel, tourism and hospitality sectors, combined with evidence of a willingness and capacity to study at Master's level, will also be considered. (Only for Msc. International Tourism Management)

## St Mary's Students Amongst Most Satisfied in the UK

The 2018 National Student Survey (NSS) has seen overall student satisfaction at St Mary's rise to 88%, the highest rated amongst institutions with university-status in London.

St Mary's climbed 56 places for overall satisfaction in the annual survey; a 3% point year-on-year increase.

60% of St Mary's courses had an overall satisfaction rate of more than 90% and Criminology & Sociology, Media Arts and Tourism Management achieved 100% overall satisfaction.

St Mary's also received high scores for:

- Learning opportunities (87%)
