ADMISSION REQUIREMENTS

QUALIFICATION FOR ADMISSION

1. Bachelor's degree in any fields from the institutions accredited by the Ministry of Education, Thailand.
2. TOEFL score of at least 575 PBT/213 CBT or IELTS score of at least 6.5 or pass the English Proficiency Examination of AU (A student whose native language is English or who has earned a master's or bachelor's degree from an institution where the medium of instruction is English may request for an exemption from the TOEFL / IELTS requirement.)
3. A score of 500 on the Graduate Management Admission Test (GMAT) or 1000 on the Graduate Record Exam (GRE) or a passing grade on AU Test.

ENTRANCE REQUIREMENTS

1. A complete application form
2. Official transcript from the previous university attended (3 copies)
3. Bachelor's degree certificate (3 copies)
4. Citizen identification card and residence registration - for Thai applicants (3 copies)
5. Passport - for non-Thai applicants (3 copies)
6. Five (1 x 1.5-inch size) photographs (formal attire, not in graduation gown)
7. Resume (3 copies)

Note : All documents must be endorsed with signature and submitted in person within the last day of application period, otherwise the application will not be considered and the applicant will not be allowed to sit for the Admission interview.
