

#### QUALIFICATIONS FOR ADMISSION

1. Eligibility for a student visa to study in UK.
2. Bachelor's degree or equivalent from an accredited institution in any fields.
3. A minimum CGPA of Bachelor's Degree is 2.00 on 4.00 scale.
4. Good command of English.
5. Computer literacy.
6. Student must have English Language test to submit with St Mary's University. The IELTS Scores of 6.5 with no component below 6.0
7. Student must obtain the CGPA for AU-MBA or AU-MS.MGT of at least 3.00 to study at St Mary's University, Twickenham, London.

Note : All documents must be endorsed with signature and submitted in person within the last day of application period, otherwise the application will not be considered.

Applicants who are graduates from overseas universities will be required to provide at the time of applying and not later, certified, attested, or notarized by competent notaries, all academic documents with the seal or stamp by the Ministry of Foreign Affairs, Ministry of Education or related department.

#### APPLICATION REQUIREMENTS

1. A completed application form
2. Official transcript of the previous university attended (1 copy)
3. Bachelor's degree certificate (1 copy)
4. Citizen identification card and house registration (1 copy) - for Thai applicants
5. Passport (1 copy) - for Non-Thai applicants
6. One (1x1.5 inches) photograph (formal attire, not in graduation gown)

**ADMISSION FEE** 1,000 THB (Non- Refundable)

#### ENTRANCE EXAMINATION

- AU English Proficiency Test
- Interview Entrance Examination

#### EXEMPTION

The AU English Proficiency Test can be exempted depending on which of the following conditions you satisfy.

- a TOEFL score of (iBT) 90 or an IELTS (Academic) score of at least 6.5 (Validation: Two years)
- a Bachelor's degree from native English speaking countries (USA, Canada, UK, New Zealand and Australia)

### St Mary's Students Amongst Most Satisfied in the UK

The 2018 National Student Survey (NSS) has seen overall student satisfaction at St Mary's rise to 88%, the highest rated amongst institutions with university-status in London.

St Mary's climbed 56 places for overall satisfaction in the annual survey; a 3% point year-on-year increase.

60% of St Mary's courses had an overall satisfaction rate of more than 90% and Criminology & Sociology, Media Arts and Tourism Management achieved 100% overall satisfaction.
