Pre-Master Program Requirements and Conditions

Eligibility Criteria:

- AU Fourth-Year Undergraduate Students: Must be in their final year with a maximum of four remaining undergraduate courses.
- Minimum GPA Requirement: Students must have a cumulative GPA of 2.00 or above.
- English Proficiency: All students are required to take the AU English Proficiency Test and undergo an English interview. If a student has received a grade of B+ or higher in ENG 1-4, the English Entrance Exam will be waived, but the interview requirement remains.
- Undergraduate Degree Completion: Students must complete their undergraduate degree coursework to progress directly into the second trimester of the MBA program.
- Course Grade Requirement: Students must earn a B or higher in Pre-Master courses to receive credit. If a grade below B is received, the student must retake the subject during the MBA program.

Pre-Master Courses:

Fourth-year undergraduate students may enroll in up to four (4) Pre-Master courses for a maximum of one (1) semester.

These courses include:

- Introduction to Management Information Systems
- Introduction to Quantitative Analysis
- Organizational Behavior
- Managerial Accounting

BRIDGE-COURSE

The MBA Bridge-Course is tailored specifically to facilitate the transition of AU undergraduate students into their Master's program



Eligibility and Conditions for the MBA Bridge-Course:

Degree Requirement:

- **Course Bridging:** Up to four undergraduate courses can be bridged, with each requiring a minimum grade of B+ to be eligible for transfer to the selected MBA program.
- **Transcript Recording:** Grades from bridged courses will be directly transferred and recorded on the MBA transcript.

Financial Information:

Tuition for Bridged Courses: Each bridged subject incurs a fee of 5,000 Baht, in addition to other applicable university fees.

Process for Enrolling in Bridge Courses:

1. **Obtaining Course List:** Please contact the Graduate Admission Office to receive the list of transferable courses.
2. **Application Submission:** After reviewing the available courses, complete and submit the AU Master, Bridge-Course form to proceed with your application.
3. **Course Participation:** Maintain consistent attendance.
